WAIVER OF LIABILITY

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

WARNING: BY REGISTERING YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE, CLAIM DAMAGES, AND SEEK COMPENSATION.

The registration is to be completed by an individual joining a member club of Australian Football League Canada (the "Organisation") who will participate in any events and activities of the organisation (collectively referred to as the "Activities") or its provincial leagues. Should the individual be under the age of 18, registration must be completed by a parent or guardian.

I, by way of registering, am aware that the activities involve inherent risks, dangers and hazards, involving all manner of injury or loss, including potentially serious or life-threatening injury and death arising from, but not limited to, the following:

- (a) the use of equipment, materials or facilities related to the Activities;
- (b) the actions or negligence of myself or other participants in the Activities;
- (c) the actions or negligence of the Organisation, its servants, agents or representatives; or
- (d) any additional risks arising out of the Activities and related events and activities.

I freely accept and assume all risks, dangers and hazards and the possibility of injury, death, property damages, property loss or any other loss or expense resulting to myself.

I hereby agree as follows:

- (a) TO WAIVE ANY ALL CLAIMS of every nature and kind at law or equity or under any statute that I have or may have in the future against the organisation, its servants, agents or representatives;
- (b) TO RELEASE THE ORGANISATION, its servants, agents or representatives from any and all liability for injury, death, property damage, property loss or any other loss or expense that I may suffer or that my respective next of kin or legal representatives may suffer as a result of my participation in the Activities, due to any cause whatsoever, including negligence on the part of the Organisation, its servants, agents or representatives;
- (c) TO HOLD HARMLESS AND INDEMNIFY THE ORGANISATION, its servants, agents or representatives from any and all liability for injury, death, property damage, property loss or any other loss or expense to any third party or other financial loss or expense, including legal expenses and costs on a solicitor-and-his-own-client full indemnity basis, as a result of my participation in the Activities; and
- (d) THAT THIS AGREEMENT WILL BE EFFECTIVE AND BINDING UPON myself, my heirs, next of kin, executor, administrator and assigns in the event of my injury or death.

This waiver from the Organisation, Australian Football League Canada (AFL Canada), does not preclude myself or the player being registered from making a claim under any sports accident coverage provided by Australian Football League Canada (AFL Canada).

I hereby acknowledge that I have read the foregoing and acknowledge that I understand its contents and meaning and approve and consent to the above. If under the age of eighteen, the registration must be completed by a parent or guardian.
